"Members Helping Members"

From its inception in 1969, the Auxiliary Emergency Fund has had a significant impact on members.

As of June 2023, the National organization has awarded more than six million dollars in grants to more than 6,500 members.

- Disaster assistance
- Temporary financial assistance

The National AEF Grant Committee reviews applications and disburses funds up to \$3000 to eligible applicants.

Only members whose dues are paid for the current year and the immediate past two years are eligible to apply.

No AEF funds are distributed at the Unit or Department level.





Did you know that the Auxiliary Emergency Fund is 100% donation funded?

- Units should send donations to the Department Secretary/Treasurer with AEF in the memo line.
- Pass the bucket at every meeting and event to collect spare change and dollars.
- Encourage members to fill water bottles with pennies, nickels, and dimes.
- Involve Juniors and SAL youth to help with collections and donations.
- All monies collected should be turned over to the Unit Treasurer.





Individual members who donate \$100 or more to AEF will receive an "AEF Members Helping Members" lapel pin.

- These donations should be sent directly to the National Headquarters earmarked AEF (pin).
- Can be a single donation or recurring monthly donations totaling \$100 between October 1, 2023 and September 30, 2024.
- Donate online at <u>www.ALAforVeterans.org/AEF</u> or text "AEF" to 1-844-940-3450 today to help members in need and get your pin. Be sure to include that you are a member in the Department of Virginia.

AEF funds are *restricted* funds and should be carried as a separate line item in the Unit's books.

National AEF awards:

- Unit Award: Unit contributing the largest amount (per capita) Award based on donations received from June 1 – May 31.
- **Department Award:** Department making the largest contribution overall Award based on donations received from June 1 May 31.
- Department Award: Department making the largest contribution (per capita) Award based on donations received from June 1 – May 31.

Mid-year reports are due December 1, 2023 and Year-end reports are due April 15, 2024.





Best Practices for Units and Districts

The person writing the checks should *never* be the one to receive copies of the cancelled checks or the cancelled checks themselves.

Require receipts for *everything*. Consider requiring a Request for Reimbursement form for tracking purposes.

Provide receipts for payments or donations received.

The Treasurer is required to provide a report at every meeting.

For any event involving money, the money should be counted by two persons together, before turning it over to the Treasurer.


Requirements

Make sure your Unit is Bonded. This protects your unit! It is a Citation requirement so make sure it is done every year.

Have you filed your Tax Exemption documents? If not, please do so and send a copy to the Department Finance Chair.

Each Unit is required to file a 990 or 990-N annually, and a copy must be sent to the Department Secretary/Treasurer **and** the Department Finance Chair to verify compliance.

Make sure your Unit has a license to solicit donations. Provide a copy to the Department Secretary/Treasurer.




About the Books

Units and Districts should conduct an Audit annually, and whenever there is change to the office of Treasurer. You've heard about this from the Risk and Compliance Chair.

Remember, the money belongs to the members, and the books should be available at any time should questions arise about finances.

Restricted funds should be maintained as separate line items.

- Monies raised for a specific purpose can *only* be used for that purpose.
- That is the only way to demonstrate that disbursements are made specific to the purpose stated when the funds were raised.



And one more thing...

Non-profits are advised or keep no more than 3-6 months of operating funds as cash reserves.

Funds raised are to be used, not held.

Holding funds sends a red flag to the IRS.

Be sure your Unit is compliant with all organizational and legal requirements.

- Nominations are due by April 1, 2024.



ROAR 2023-2024 Responsibilities, Obligations and Requirements

The Purpose of the ROAR committee is to tabulate Unit compliance with the responsibilities, obligations, and requirements as stated in the Department of Virginia Constitution and Bylaws, Standing Rule 31A and 31B in order to earn a Meritorious Citation.

Criteria to be met:

1. All required citation payments must be made to the ALA Department. A record of Required citation payment made is to be obtained from ALA Department Headquarters. Citations payments/assessments are the following:

Children & Youth	Entertainment of Veterans
VA & R	15% of all Poppy Donations Received
Bonding	Building Fund

2. Nine Monthly Reports Must be submitted to the Department President, Vice President, Strategic Planning, District President
